Thank you to all of you who sent congratulatory messages in view of my 'new' job as posted on LinkedIn. While I appreciate all of the attention and the kind words, the recent 'change' is in name only. I was hired as PMI's Chief Operating Officer of PMI in 1998 and have served as CEO continuously since that time. So, new title; same role!

Last year, PMI took a look at a number of governance issues. You have seen some of the outcome of that work: a smaller Board of Directors with shorter terms and a shift from two conferences per year to a single annual conference. Another change was to my title. In the "for-profit" world, there is no doubt about the leadership role of a "CEO." While the term "Executive Director" carries the exact same meaning in the "not-for-profit" world of industry associations, some people have been confused about the role and the interface with the volunteer leadership of PMI. In benchmarking other associations like ours, we learned that many groups are moving away from using the Executive Director title for their top executive, to that of CEO in the name of clarity.

The PMI Board of Directors is headed up by an elected president (this year it is **Tim Kilbane** of Symmons, as you know) who takes the lead in the governance of the organization. The job of the PMI volunteer president and its Board of Directors is to partner with the hired PMI CEO to identify the "what" of what needs to be done and to set the strategic direction of the association. Working together, this team sets goals and metrics for the organization. The job of the PMI CEO then is to determine the "how," which includes staffing, hiring consultants, allocation of resources, and general management of the association as a business. The PMI CEO and the staff, hired by and to support the PMI CEO, help

to provide continuity, stability and institutional knowledge as administrations change each year and the volunteers serve and complete their terms of office.

It's a winning combination!

Last year, we saw the revitalization of the Strategic Advisory Council (SAC), comprised of six PMI member company CEOs. As the name implies, these individuals have volunteered to provide support for the Board of Directors and the organization as a whole by offering guidance and advice on key issues. This year's SAC includes: **Hugh Ekberg**, Kohler, **Tim Ferry**, Insinkerator, **David Lingafelter**, Moen, **Tim O'Keeffe**, Symmons, **Todd Talbot**, Fluidmaster and **Ray Fisher**, Fisher Manufacturing, who serves as the liaison between the SAC and the Board.

You can be sure that PMI is in good hands with these groups actively looking for ways in which PMI can impact industry issues, while enhancing the value of the organization to members. Come see some of the successes and results at the Spring Conference in Charleston!

Managing Risk and Communicating Value

One phenomenon that exemplifies the climate of manufacturing in this new century is the need to continuously improve every aspect of our

performance. There is no status quo and the gap between leading edge and early adopters gets wider every year. The performance of industry associations is no different as PMI is continually looking to improve the way we serve the plumbing manufacturing industry.

As one of the key tenets of Six Sigma training, the acronym DMAIC represents Define, Measure, Analyze, Improve and Control. The DMAIC process is a method to continuously improve the product or service in which a business is engaged. The step to "measure" is challenging, and, in the case of an industry association, sometimes the most difficult.

We are going to present a tool at the PMI Spring Conference that will enhance the way industry issues are measured by our members. Here at PMI we often joke about the task of "drinking from the fire hose" when communicating the multitude of issues we encounter in the course of a year. By quantifying the inherent risk of these issues in terms of opportunities or threats, we begin to measure the impact from the external business environment in which PMI resides.

Risk assessments have been traditionally used by manufacturers to make internal decisions on product designs and manufacturing options. The workshop we will have in Charleston on March 4th will present an approach to assess the impact of the multitude of issues we face and provide a tool that can be used

to summarize current and future risks while communicating PMI's value.

When looking at all of the external issues we deal with annually, it becomes difficult to summarize them as some are addressed quickly, some take years to resolve and others are ongoing issues that may never be completely resolved. These challenges can have a positive or negative impact which changes with the potential timing of these issues along with anticipated probabilities of occurrence.

When we look at the low-lead issues from states, as an example, PMI and its members took the threat of a patchwork of regulations and turned it into an opportunity of harmonizing into a national bill. By referring to the NSF standards, we provided a single target in order to prevent a multitude of compliance levels that would have created chaos in the market. Opportunities and

threats always exist in the short and long term future, but quantifying them as a group can help to establish overall risk levels needed for strategic planning. The workshop in Charleston will present a method to do this.

The strength of the plumbing manufacturing industry lies in our ability to respond to all external risks, positive and negative, in a way that maintains a level playing field, creates an improvement in our products while maintaining health and safety, as well as consumer satisfaction. PMI's role is to provide a forum for plumbing industry leaders to address these risks as a group and stay ahead of the continuous flow of issues. The use of a risk assessment tool can aid in an overview of current and future issues and prioritize the industry's focus.

We look forward to seeing you in Charleston, SC on March 2–5.
